## **CONSTRUCTION COMMENCES AT COUNTY OPERATIONS CENTER IN KEARNY MESA**

-- Sustainable office campus will consolidate key county services to one location and ease public access to government services --

SAN DIEGO – The San Diego County Board of Supervisors and developer, Lowe Enterprises, hosted community leaders and local officials at a groundbreaking ceremony April 8 to kick off construction of the first two office buildings at the new County Operations Center in the Kearny Mesa area of San Diego. The two 150,000-square-foot office buildings are part of a larger planned redevelopment of the 38-acre site. When completed, the new campus is expected to include 900,000 square feet of modern, efficient office space, built to LEED Silver Certification standards, along with a conference center and cafeteria and two multi-level parking structures. The project will consolidate county operations from two sites to one new campus.

“We will deliver to the County state-of-the-art facilities that will allow them to consolidate operations to their own campus,” said Mike Mc Nerney, senior vice president, Lowe Enterprises Real Estate Group. “Staff will have a highly professional environment that will foster collaboration. The landscaped, open spaces connect the buildings throughout and offer options for work breaks or casual conferences.”

The County Operations Center, located on Overland Avenue, will be developed in three phases. Phase one includes the development of a central plant that will provide the mechanical systems to run the entire campus, two 150,000-square-foot, four-story steel frame office buildings and a seven-level parking structure. The office buildings will feature sustainable design incorporating a variety of energy efficient, green building technologies. Abundant windows will allow for natural light, while energy efficient roofing and glazing systems will reduce heat gain. Landscaping will feature water efficient plants and an irrigation system to reduce water usage. Phase one also includes offsite improvements to mitigate traffic impacts.

Completion of the first phase of development is slated for fall 2010.

Future phases of the development will include four additional 150,000-square-foot, four-story office buildings, identical to the buildings in phase one, a 20,000 square-foot conference center and cafeteria and another parking structure.
